Course description

This course studies the historical and cultural relations between Spain and the English-speaking countries, principally the United Kingdom, Ireland, and the United States. It will focus on political, religious, and socio-cultural aspects through time and down to our days.

Prerequisites

CEFR English Level B2 (required); CEFR Spanish Level B2 (recommended).

Aims

The aims of this course are the following:

- ✓ To introduce students to the principal events marking out the history of the political and religious relations between Spain and the English-speaking nations.
- ✓ To present students with an overview of their cultural and artistic exchanges across history.
- ✓ To develop the students' skill to examine the dynamics of their societies and institutions and of the perceptions and representations of the other they constructed.
- ✓ To familiarize students with the terms and concepts needed to discuss historical and cultural relations and exchanges.
- ✓ To develop the students' ability to identify, analyze, and interpret sources and artifacts relating the subject.
